01. Ministry of Public Security

1.1. Introduction

The Ministry of Public Security was established as a Cabinet Ministry with the amendments made to the scope of the then Internal Security Division by the Gazette Extraordinary No 2202/25 dated 20.11.2020. Since then the scope of the Ministry was subjected to several amendments. The Ministry and its institutions ensure a suitable environment which enables all the general public live freely without fear and apprehension maintaining public services efficiently and public friendly manner while ensuring citizens identity as per policies and plans formulated by the government for the year 2023.

The Ministry of Public Security and its institutions put their shoulders to the wheel to create a suitable and conductive environment to the citizens so as to live freely without fear and apprehension, to ensure identity of citizens locally as well as internationally, prevention of drug menace and dangerous drug abuse and to establish a society with lawful citizens through functioning the international and local Non-Governmental Organizations in the country in line with the policies of the government.

Especially, the Ministry of Public Security has taken necessary steps to solve issues related to promotion and training of officers in Sri Lanka Police and special attention has been drawn for provision of adequate technical and infrastructure facilities for them. It is anticipated to upgrade a people friendly Police Service.

This Ministry along with all the institutions has gone onto shoulder enormous onus of carrying out public services that ensure personal identity and to safeguard public security efficiently and to maintain in a public friendly manner. This Ministry constantly assist in the development process of the country with formulating plans and formal implementation of those while preparing of policies, guidance, implementation, supervision, performance evaluation and follow up.

Vision

"Create a safe, secure, peaceful and drug-free Sri Lanka where citizen identity is affirmed"

Mission

Formulate and implement policies and strategies to create the country that eradicates the menace of crime, terrorism, drugs and preserves law and order and affirms the identity of legitimate citizens."

Goal

Provision of a public- friendly service by performing special prioritized tasks related to ensure public security and citizen identity based on the Government polices with the intention of achieving sustainable development goals and targets.

Objectives

- To formulate policies required to create a suitable environment ensuring security and identity of all the citizens and make directives.
- To improve the Police Service as a professional service through provision of new technological devices and training in view of enhancing efficiency and productivity.
- To strengthen Intelligence division and Functional divisions of Sri Lanka Police enabling prevent and curb extremism, terrorism, robberies, murders, underworld activities and Narcotic hazard.
- To compile plans towards infrastructure development of Sri Lanka Police and maintain supervision and follow-up process in regard to activities.
- To introduce technological appliances and methods in order to control and monitor traffic congestion to minimize accidents, disabilities and deaths caused by road accidents.
- To prepare a background ensuring local and foreign identity as per international standards.
- To implement suitable strategic programmes to curb narcotic hazard and misuse of dangerous drugs.
- To take actions to register all the active Non governmental organizations in Sri Lanka and to ensure that those organizations are functioned within the policies of the government.
- Preparing opportunity to contribute to the development process of the country with the coordination of Non government organizations within the national policy frame.

Special Priorities

- Improving the service standards of the Sri Lanka Police with the objective of ensuring public safety.
- Implementing the programme with religious centres, social organizations and public and private sectors to get rid the society from the menace of drugs at the community level as well as for children in schools and educational institutions, public and private work places.
- Take necessary measures to prevent extremism and terrorism with the aim of ensuring internal security.
- Control and suppression of robberies, murders, anti-social activities and crimes to keep public life safe.
- Maintaining the necessary care for all citizens of the country, especially for women and children, to live their lives freely.
- Reorganizing and modernizing the Traffic Police using modern technologies and techniques to enforce a systematic traffic regulation system and legal framework in order to prevent disorderly use of vehicles on roads, road accidents, deaths, injuries and hospitalizations and irregular and careless driving, violations of lane rules and road signs, as well as to reduce traffic congestion, especially in urban areas, caused by irregular driving and roadside parking.
- Preparing opportunity to contribute to the development process of the country with the coordination of Non governmental organizations within the national policy frame.
- Enhancing Immigration and Emigration affairs and maintaining as an efficient service.
- Preparing background to ensure local personal identity enhancing and maintaining as an efficient service.

1.2. Quarterly Progress of the Ministry

• Human Resources Development

The Management services Department has approved a staff of 126 including Chief Internal Auditor on 10.06.2021 once the Ministry of Public Security was established as a Cabinet Ministry. Even though 45 of Management Services Officers were approved only 26 officers are attached at present. As per the instructions made by the Ministry of Public Administration action was taken to attach Development Officer. It was able to fulfill 91% in 2022 out of the total requirement at the end of the 3rd quarter and to maintain the duties of the Ministry with maximum efficiency.

• Training Courses

It is vital to provide training required to enhance the knowledge, attitudes and skills required by the staff ensuring the Vision of the Ministry. Officers of the Ministry were able to join several training programmes accordingly to develop knowledge, attitudes, skills, positive thinking. Three staff officers in the Ministry were given local training to develop their capacity while other 09 officers were given Tamil language proficiency training.

No subjective foreign training opportunities were given to the officers in the Ministry and action has been taken in that regard.

To commence special tasks formally

Thirty Cabinet Memoranda were submitted to the Cabinet during the period under review based on the several functions such as human resources development, enhance welfare, infrastructure development, enhance procurement carried out by the Ministry and institutions within a legal frame in a formal and transparent manner. Necessary steps are underway in order to perform functions of the Ministry and its institutions as per approvals and recommendations granted by the Cabinet of Ministers.

Test kits to identify drivers who drive after alcohol

This project was introduced with a view to identify drivers who drive after alcohol and thereby to reduce deaths occurred by increasing fatal road accidents and take legal actions against them. As a first step, Rs 10 million was allocated out of the National Assembly Fund on Road Safety to obtain test instruments from National Dangerous Drugs Control Board. The 50 test kits purchased were handed over to Sri Lanka Police on 06.09.2023 with the approval of the Minstry of Transport and Highways. At present tests are underway successfully using those test kits with the assistance of relevant parties such as the Sri Lanka Police and National Dangerous Drugs Control Board.

• Eradicating Child abuse

It is anticipated to prepare a mechanism joining with Sri Lanka Police and other institutions who work for child abuse in view of finding a permanent solution to prevent child abuse. Action is being taken to initiate decisions joining with the Ministry of Women and Child

Affairs, Ministry of Justice, Sri Lanka Police, National Child Protection Authority, Department of Probation and Child Care Services and other relevant sectors.

• Get the future generation free from drug addiction

Objective of this initiative is to provide a solution in line with the new policies of the new government in order to get the students and youth free from drugs and to present drug dealing which spreads in the island in a massive scale. A number of activities are carried out in collaboration with the Ministry of Education, Sri Lanka Police and National Dangerous Drugs Control Board in order to implement suitable programmes. Especially action in brief taken to conduct proper counseling programs for the school children and the youth while training the officers.

• Delimitation of Deputy Inspector General divisions

A Committee was appointed with the approval of the Cabinet of Ministers to prepare a proposal with solutions for delimitation issues identified where administratative districts and provincial boundarious are not tallied with Deputy Inspector General Divisions. Having identified the administrative boundaries and police boundaries which are not tallied the Committee has prepared a report with solutions and forwarded the same to the President's office. Action Plan has already been prepared with the Minstry and the Sri Lanka Police to carry out the solutions approved and further actions are underway.

• Estalishing new police stations and police posts as per community police concept

A new concept of Community Police was introduced in view of providing police service efficiently while creating a deciplined, loyal and virtuous society. There were 494 police stations up to the year 2021 and legal approval was obtained to establish 205 new police stations and 119 police posts. 113 police stations and 39 police posts were established upon the approval. Accordingly 607 police stations were established at present.

• Spot fine payment system

The proposed project proposal to initiate under 03 stages with the joint collaboration of Sri Lanka Police, Department of Motor Traffic, Sri Lanka Information Communication Technology Agency and all the relevant institutions in view of finding the joint electronic solution for collecting spot fine for vehicle offences and augmenting the amount of fines accruable instances collected making the payment of such fines facile. Approval of the Cabinet was granted by the Cabinet decision No /23/0472/026/004-11 dated 18.04.2023 in this regard. Accordingly selection process of a suitable institution to implement approved procurement process is underway with the Ministry of Transport and Highways.

Installation of an Incinerator for disposal of drugs

Having considered the national value of disposing drugs which was granted court order to arrest and dispose, the Ministry takes action accordingly. The land in Laktowatta, in Vanathawilluwa was selected to install an Incinerator and actions with regard to purchase the Incinerator and construction of building to dispose drugs were carried out joining with Sri Lanka Police, Sri Lanka Navy and Special Task Force.

Reinstating the officers who have vacated the post

1039 officers out of 2297 police officers in Sri Lanka Police and Special Task Force who have given vacation of post orders were called for an interview and 910 officers qualified were reinstated in the service and as a fourth step recommendation was requested from the Secretary Public Service Commission to reinstate another 62 officers.

• Granting relief to the dependents of the officers, retired officers who have deceased and disabled while on duty...

As per the Cabinet decision granted to make special provisions to officers who have deceased or totally disabled whilst on duty of safeguarding law and order action was taken to grant Widows and Orphans Pension to the prejudiced officers who were attached to the Reserve Service prior to absorb in to the Regular Service. Accordingly 05 officers who have made retire from the service on medical grounds due to disability caused by terrorism and having more than 10 years of service and less than 15 years of service were accordingly granted entitlements.

Approval was granted by the Cabinet memorandum submitted on 09.08.2023 to grant pension entitlements to the dependents of 34 officers in Reserve Service who have deceased without contribution to Widows and Orphans Pension scheme upon terrorist activities or natural disasters and not absorbed to Regular Police Service.

Granting allowances to special divisions and ranges in Sri Lanka Police

Sri Lanka Police plays a special role in the security sector. Safeguarding law & order, ensuring national security, VIP security, obtaining information, investigations, motor traffic control, curbing crimes and drug menace are its main functions. Officers in VIP security division for retired Presidents, Prime Minister's Security division, Ministers' Security division, Special Task Force and Intelligent service are paid with a special allowance of 1/3 of their basic salary. Also as per the Cabinet approval dated 02.10.2023 actions are underway to make ½ of allowance from the basic salary for the officers who have deployed in Crime Investigation division, Drug raid activities, supporting of protests and riots controlling ,intelligence service and investigations to safeguard law & order.

1.2.1. Towards a rapid solution for public grievances

• 118 Emergency call service

Main objective of 118 Call service is to obtain information on State Security and terrorist activities. In addition, rapid investigation for complaints against officers in Sri Lanka Police and Three Forces activities were carried out by this service. Also the Ministry joins its hands together with Sri Lanka Police to obtain complaints, proposals, allegations and grievances. This is a round clock service. During the past 9 months 70491 complaints were received and action has been taken to take necessary measures in respect of all the complaints. 118 Call Centre is active round the clock in the Ministry under the direct supervision of the Secretary of the Ministry.

Progress of Police and Public Grievances day

Virtual public days have been conducted each Wednesday from 01.01.2023 to 30.09.2023 under the patronage of the Hon Minister, Secretary, Officers of the Ministry, Senior officers from the institution under the purview of the Ministry providing an opportunity to the general public to refer complaints against public institutions and officers, to obtain relief in respect of matters that are delayed or not yet initiated by the Ministry or other Institutions. 2236 complaints and appeals were received from police officers and 696 complaints were received from civil citizens. It was able to solve 1113 complaints and complainers did not participate in 39 complaints while 314 complaints were rejected for several reasons.

1.2.2. Reviewing the progress of the development programmes

Quarterly progress review meetings were held to review the progress of the development projects initiated out of the annual capital provisions of the Ministry and its institutions. Necessary instructions were given and measures were taken accordingly to solve issues with relevant parties on occasions where issues arose in projects for construction and purchasing of goods. Field visits were also made on projects that were held due to the inefficiency of contractors and provisions were taken to revise those.

With the broadening of the scope of the Ministry in the latter part of 2022 new institutions were joined with the Ministry. Accordingly instead of calling all the institutions to the Ministry to review the progress, the Ministry visited their premises and observed the activities carried out by them. Since this system was more practical it was decided to adhere to the same procedure in the future as well.





• Initiating Internal Audit plans for the Ministry

- Action was taken to Audit queries, Annual Action Plans, progress of the Procurement plan including other financial and administrative activities carried out as per relevant Circulars and laws and regulations. Audit & Management Committee meetings were conducted for the first, 2nd and 3rd quarter of the Ministry as per the prepared Audit Plan. Accordingly, it was able to cover 75% of the Internal Audit Plan prepared for the year 2023 as of the 3rd quarter.
- The Audit was carried out during the period by the Internal Audit division through the fields such as Advance B Account, General Deposit Account, Assess Management, stores inspection, Annual Board of Survey, Disposal Inventory control, Annual Action Plan progress of the projects, Personal file maintained, Leave and transport maintains, Ministry website and Audit quires were issued at one per each division.
- Also during the year under review, payment vouchers of Special Task Force was checked. Auditing was carried out at the National Dangerous Drugs Control Board and Galle Rehabilitation Centre. Action was also taken to examine the registration of Non-governmental Organizations in the National Secretariat for Non-governmental Organizations, one Audit query on financial and other divisions, Annual Plans, Progress review for micro loan while one Audit query was made in relation to E-National Identity cards project of Department of Registration of Persons.

1.2.3. Creating inter co-operation

As the first step after the establishment of the Ministry of Public Security, the Hon. Minister met several parties and held discussions to obtain their co-operation. Foreign representatives and Cabinet Ministers were among them.

• Bilateral Agreements

This Ministry entered into Memoranda of understanding in view of empowering law within the Government and Foreign countries, training courses, obtaining technical equipment and instructions for information facilities, bring Sri Lankans in abroad illegally back to Sri Lanka.

• Human trafficking

This Ministry is directly functioned as a chief stakeholder of local Task Force for mitigating human trafficking and Sri Lanka Police renders their cooperation through Human Trafficking Crime Investigation Unit. Also virtual International Conference on synthetic drug prevention was also held under the patronage of State Secretary of United State Mr. Antony Blinkan of State Department of United States. Ministers in charge of this subject and officials from United States of America, United Kingdom ,Israel, Germany, Italy, Argentina, Belgium, Canada, Australia, South Africa, Korea were participated in this Conference while Sri Lanka was respresenting Hon. Tiran Alles the Minister of Public Security. Main objective of this was to stand together against synthetic drug production and distribution.

 Diplomatic relations between France and Sri Lanka was strengthened through the discussions held with Hon .Jonfransuwa pakthe, the Ambassador In France and Hon Tiran Alles, the Minister of Public Security. The Ambassador assumed their wholehearted assistance to strengthen the relations. It was discussed the measures to prevent illegal Sri Lankan immigrants entering into islands in France.



- A courtesy visit was held between Hon. Dominiq Furgler, Ambassador in Switzerland and Hon Tiran Alles. Hon. Dominiq Furgler assured their assistance to provide technical assistance required to enhance Sri Lanka Police and to conduct training workshops for Police officers.
- The Switzerland Ambassador further stressed the importance of safeguarding human rights and establishment of Truth Commission. Hon. Tiran Alles, the Minister of Public Security added proposals that the Truth Commission should not be biased.



 A courtesy visit was also held between Hon. Devi Gustina Tobing, Sri Lankan High Commissioner to Indonesia and Hon Tiran Alles. Attention was drawn at the discussion to further enhance economic and political bilateral connections between two countries. Also the High Commissioner affirmed their further cooperation for Sri Lanka during the future as well.



• In the meantime a courtesy visit was held between Hon. Damiano Francowigh, Ambassador in Italy and Hon. Tiran Alles, the Minister of Public Security on diplomatic relations. Discussions were held on the matters such as controlling and prevention of illegal immigrants and drug trafficking and measures to be taken by the Ministry of Internal Affairs in Italy and the Ministry of Defence.

2.1. Sri Lanka Police

2.1.1. Introduction

The Police Department was established as per the Police Ordinance No 16 of 1865 in the period of British rule on 03rd September 1866, with a view to rendering an organized service to the general public. From then to date over a period of more than 156 years the Sri Lanka Police is engaged in the responsible task of establishing "Law & Order in the Country."

Sri Lanka Police is entrusted with a multitude of special responsibilities to safeguard the society ensuring protection in every field. Elimination and prevention of crimes, overcoming narcotic hazard, elimination of corruption, traffic control, protection of environment, providing relief to the public at disasters and VIP Security are prominent tasks in relation to the scope of Police.

A Police cadre of over 90,000 is in service round the clock in the categories of Senior Gazetted Officers Grade, Inspectorate Grade and Junior Grade to perform above duties throughout the Island. These officers render a prominent duty as Regular service, Reserve service and Special Task Force. In addition to this cadre of more than 4000 Civil Officers assist in the duties in Sri Lanka Police.

With the historical mission of 156 years more than 607 Police Stations have been established to provide their service more efficiently. In addition services of Sri Lanka Police is in operation through organized institutional structure of 45 Territorial divisions and 81 Functional divisions.

2.1.2. Quarterly progress of Sri Lanka Police

The Sri Lanka Police is entrusted with main tasks such as elimination and prevention of crime, overcoming narcotic, protection of environment, providing relief at disasters and VIP security in order to safeguard the law and order in the country. Issuance of clearance reports and 119 Emergency Call centre also function to render services for the public.

All the police stations are graded such as Headquarters, police stations and general police stations. Accordingly there are 82 Police Stations in A 1 grade, 103 Police stations in A2 grade, 142 in A3 grade, 152 in B grade, 94 police stations in C grade, and 54 police stations in D grade and 607 police stations are graded as at 30.09.2023. Chief Inspector is in charge of the Headquarters station while an officer in charge is deployed for other police stations. Inspectors of Police, Sergeants of police and Constables of Police directly serve for the public. Also approximately 1291 officers are deployed for special services such as medicine, nursing, engineering, chef, Technical Information Technology to obtain expertise knowledge. In addition more than 4000 officers in the Sri Lanka Administrative Service, Sri Lanka Accountancy Service, Sri Lanka Planning Service Administrative Officers, Translators, Development Officers, Management Assistants, Office Assistants as well as officers in departmental posts such as criminologists, Research officer, Development Assistant and Number of labours serve police duties. Accordingly Sri Lanka Police performs a special duty utilizing the human and physical resources they have. The progress achieved as follows.

• Reporting and solving crimes

• Absolute amount of reputed crimes and the comparative amount of giving solutions to so reported crimes is a key indicator of progress of Sri Lanka Police. The table below represents the amount of reported crimes and solutions made during the first three quarters of 2022- 2023.

• Welfare activities

Medical treatments are given to Police Officers and their family members as well as to retired officers and their family members from Police hospitals in Narahenpita and Kundasale.

In addition 16,911 clinics were held from January to 30th of September 2023. Treatments were given to 7391 from Outreach division and 418 were given residential training. Also Rs. 1,205,538,306.77 was spent to purchase medicine and other equipment required by the police hospital during the year under review.

• Enhancing of Transport Facilities

Since 50% of vehicles out of vehicles attached to Sri Lanka Police are older than 10 years action was taken to purchase 750 jeeps under Indian Credit Line. As per a Cabinet decision reached on 11 January 2022 approval was granted to purchase 750 jeeps in the year 2022 and 2023.

Action was accordingly taken to obtain 125 jeeps during the year 2022 and more 375 jeeps in the year 2023 and total of 500 jeeps.



• Programmes and projects anticipated to implement in 2024, 2025 and 2026

- Purchase of Single cabs for Police Stations in Northern Province out of Rs.300 million under Indian Credit line.
- It is anticipated to obtain 384 vehicles of 9 models under JICS.
- It is anticipated to obtain 114 vehicles under 06 models and spare parts required to repair Scorpio Jeeps under Indian line of Credit.

2.1.3. Progress of Development Projects

• Building Development

Police Stations, Officers' Barracks and training centers are constructed to develop infrastructure facilities in Sri Lanka Police for the year 2023. Rs. 800 million was allocated to 26 projects. Out of the provision of Rs.800 million allocated in respect of construction of buildings in Sri Lanka Police the expenditure incurred as at the end of the first 3 quarters is Rs.115.7 million.

2.2. Special Task Force

2.2.1. Introduction

With the objective of providing security to the Northern region due to escalation of terrorist activities during the early part of the decade of 1980 and also for the purpose of combatting such terrorist activities, a team comprising 60 police officers were selected for establishing a special armed force in the Department of Police after giving them a special weapon training through Sri Lanka Army and they were first inducted in service at the police stations in the Northern region for providing security to such places. As this small unit met with success, it was established as the "Special Task Force" with gradual expansion and training from foreign consultants. They were later deployed in the North and East for fighting terrorism thereby paving way for a peaceful situation in the country.

At present more than 7,500 officers were deployed in 71 camps and 05 sub posts in the Expressway covering the entire Island to assist in Sri Lanka Police to raid and take legal actions against organized crimes ,drug trafficking, large scale deforestation ,illegal gem mining and various kind of damages done to the environment.

In the forefront of their tasks among others is the duty of ensuring the security of His Excellency the President, Hon Prime Minister and other dignitaries including the foreign delegations and Heads of states visiting the Island.

Objectives and Functions

- i. Counter terrorism operations
- ii. Suppression of organized crimes and drug prevention
- iii. VIP security
- iv. Arrests in regard to environmental offences
- v. Provision of security for foreign delegations
- vi. Search and bomb disposal duties
- vii. To assist in Sri Lanka Police to safeguard law & order
- viii. Fire extinguishing in expressway and life saving duties
- ix. Special training courses for Three forces, Police officers and foreign institutions

2.2.2. Quarterly progress of Special Task Force

• Human Resources Development

Approved cadre in Special Task Force is 10,743 and the actual cadre as at 30.09.2023 is 7486 and 1058 promotions have been granted as personal to the officer during the period under review. 821 orders were given. The number of vacancies within the institution is 3494. All recruitments are temperorily suspended due to the present situation of the country.

• Training and development

During the year under review 1525 officers were trained through 61 special training courses to enhance their knowledge. Also total of 1751 officers including 226 Special Task Officers were given training through 32 training courses granted by external institutions. In the mean time 245 officers and civil citizens in other institutions were given training for 20 courses conducted by Special Task Force Training school.

It was able to arrest 272 suspects with 363 illegal firearms shared within the island by organized crime groups, drug dealers. Furthermore actions have been taken to raid 79 acres of Cannabies chena, 1,084.237 kg of dry Cannabies and Kerala Cannabies, 10.642 kg of Heroine, 14.904 kg of Ice, 615 Sand cubes, 4,231 planks and logs. The fine collected by the government through these raids within this period is Rs. 17,720,100.00.

• United Nations Peace Keeping Mission

Required training was given to deploy 200 officers in United Nations Peace Keeping force duties out of them 160 officers in armed police duties while 40 other officers given training in special weapon and strategies. 98% of purchasing of required vehicles and goods were already finalized.

A group of United Nation officers has arrived and promoted the Special Task Force Peace Keeping force up to United Nations Peacekeeping Capability Readiness System (PCRS) Level 2.

In the meantime it was recommended to promote Peacekeeping force of Special Task Force up to Level 3 and referred for approval of relevant United Nations divisions and they have confirmed it in writing. Letters required to call United Nations group for observation for the final test were already sent to United Nations Head quarters.

Once the tests were finalized it would be promoted to Rapid Deployment Level - (RDL) and from then they are deployed for peacekeeping duties within 60 days. Also action is been taken to pay 25% from the maintenance cost from the date of promotion to Rapid Deployment Level - (RDL) by the United Nations Organization.

Officers were nominated with regard to the calling off names by the Ministry of Foreign Affairs to appoint a Committee comprising of officers from Three forces, Sri Lanka Police, Special Task Force and the Ministry of Foreign Affairs to solve issues in regard to peacekeeping duties and training.

The project of United Nations Peacekeeping force duties was initiated in 2017 and at present it is in the final stage. Since it is possible to deploy officers for United Nations duties at the end of this year further actions have to be taken at diplomat level.



• Infrastructure facilities development

• Two buildings in 60 x 20 were renovated spending Rs. 7.18 million in order to develop resident facilities of officers in Special Task Force Trincomalee camp.







• It was finalized the constructions of 36 fully completed quarters at a value of Rs.289 million in Kalapaluwawa for married officers from Police Constable post to Chief Police Inspector post (male/female) for Special Task Force.



• Action has been taken to renovate the building spending Rs.15 million to develop infrastructure facilities in Special Task Force Headquarters.

2.3. Department of Immigration & Emigration

2.3.1. Introduction

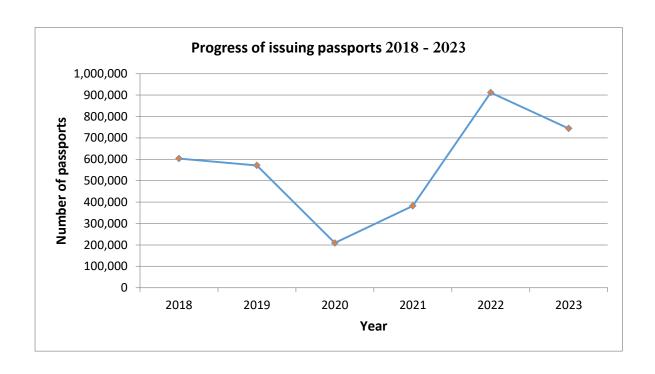

Progress of issuing Visa

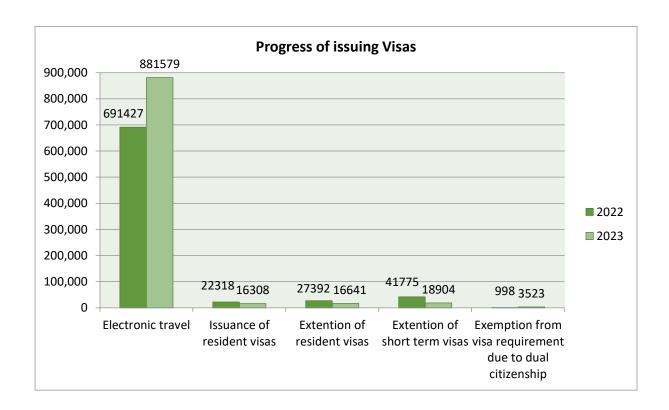

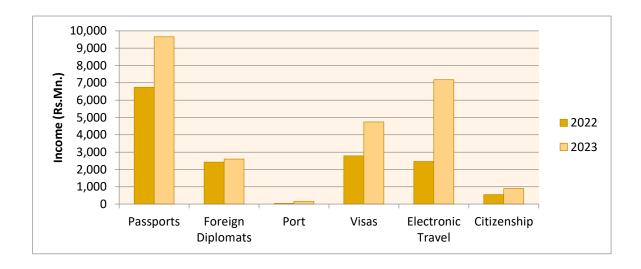

2.4. Department for Registration of Persons

2.4.1. Introduction

As per the provisions of the Registration of Presons Act No. 32 of 1968, the Department for Registration of Presons began registering and issusing identity cards to legal residents of Sri Lanka over the age of 18, beginning in 1972. Thereafter, in compliance with the provisions of Registration of Presons (Amendment) Act No. 8 of 2016, the age limit for registration of persons was amended as 15 years effective 07 July 2016.

The head office of the Department for Registration of Presons, established at Keppetipola Road, Colombo 05 since inception, was relocated to the "Suhurupaya" building at Subhuthipura Road, Battaramulla, on September 26.2016.

Although the National Identity Card was prepared only in Sinhala at the beginning of the department, this department started issuing National Identity Cards in both Sinhala and Tamil languages on February 28.2014, as per the order given in relation to the Human Rights Petition No.SC Application No. 93/2013 (F/R) filed at the Supreme Court requesting to issue National Identity Cards in both Sinhala and Tamil languages.

The issuance of smart National ID Cards in all three languages Sinhala, English and Tamil began on 27.10.2017 as the first step under the Electronic National ID Card project, which is currently being implemented to speed up the National ID Card process.

• Progress on online data verification process of Identity Cards

From 2019 to 30.09.2023, 132 institutions have requested information verification service of Identity Cards through online system. Memoranda of understanding have been signed with 88 institutions for the above methodology. Also, during the period from 01.01.2023 to 30.09.2023, requests have been submitted from 07 institutions and Memoranda of understanding have been signed with 12 institutions that had previously requested.



• Progress of the Record Room

- > Steps have been taken to create efficient record room by introducing new formats to measure progress of the record room activities and by obtaining weekly/monthly reports.
- Measures have been taken to provide information with more efficiency upon the inquiries made by the Legal division of the Department regarding the applications. Accordingly, priority has been given for one-day service where the search of applications will be done within two days and for other applications where the priority is not mentioned, the search of applications will be done within 05 days.
- ➤ Through regular monitoring and reporting of lapses in sending the completed applications and stamped envelopes to the record room by the Divisional Secretaries, it was observed that the omissions have been reduced by about 70% compared to the year 2022.

• Progress in activities related to the Registration of Presons Act

The final draft of the amendments made to the Registration of Presons Act No. 32 of 1968 on issuance of Sri Lanka Unique Digital Identity Card has been submitted to the Department of Legal Draftsman.

As the draft amendment regulation for the Registration of Presons Regulation No.01 of 2017 related to charging fees for the services mentioned in the Registration of Presons Act No. 32 of 1968 has been passed by the Parliament, the said regulation draft has been sent to the Government Press for printing.

• Contracts with other institutions

A Memorandum of Understanding has been entered into with the Department of Immigration and Emigration to provide services of the Regional Offices of the Department for Registration of Presons for online passport processing

• Progress of Internal Audit Activities

The progress of the Internal Audit Unit is 72% as the Internal Audit Plan of 2023.

2.5 National Secretariat for Non-Governmental Organizations

2.5.1 Introduction

National Secretariat for Non-Governmental Organizations is an institution established under the Act on Registration and Supervision of Voluntarily Social Services Organizations No 31 of 1980 to ensure that financial and other resources received by Non-Governmental Organizations thorough local and foreign sources are utilized only for the development activities within the legal and policy framework in the country. Supervision of the values of the projects that are initiated by NGOs only for the welfare of the beneficiaries while creating a conducive environment and freedom to partners in the development in the island are performed by them. The main functions of Non-Governmental Organizations are to contribute actively to create a better, developed country thorough guidance, supervision and coordination of local and foreign Non-Governmental organizations and Community based organizations.

• Human Resources Development

Approved cadre of National Secretariat for Non-Governmental Organizations is 77 and the actual cadre as at 30.09.2023 is 58. Accordingly it was able to fulfill 75% from the total cadre as at the 3rd quarter 2023 and the duty of the National Secretariat for Non-Governmental Organizations is maintained with maximum efficiency.

• Progress of the activities

National Secretariat for Non-Governmental Organizations renders its services under 5 main divisions and they are Non-Governmental Organizations Registration division, Recommendation for Visa and work permit, Supervision division, Investigation division and Micro-Finance Division.

- **I.** The Legal draftsman has finalized the draft act instead of the prevailing Voluntary Social Services Organization Act no 31 of 1980.
- **II.** Procurement process has been started following the approval from the line Ministry to update the official website.
- **III.** Preparation of an Action plan with the coordination of the Financial Intelligence Unit of Central Bank to avoid the funds coming to the island thorough Non-Governmental Organizations for terrorist activities or illegal actions.
- **IV.** Supervision and monitoring of all the Voluntary Social Services Organizations / Non-Governmental Organizations functioned at district and divisional level by National Secretariat for Non-Governmental Organizations.
- **V.** Establishment of a district coordination unit for the expansion of district supervision activities.
- **VI.** Establishment of Colombo district Resource Center as an initiative of district Resource Center.

VII. Recognition, Supervision and guidance of Non-Governmental Organizations with a view of rendering a qualitative and efficient service and to take actions to smooth functioning of activities such as issuance of visa for the foreigners who visit Sri Lanka for the duties at Non-Governmental Organizations.

2.5. National Dangerous Drugs Control Board

2.6.1 Introduction

National Dangerous Drugs Control Board is a statutory board established under the National Dangerous Drugs Control Board Act No 11 of 1984. Implementation of the national policy on prevention and control of the misuse of dangerous drugs, engagement in drug prevention measures extending assistance to various institutions and departments to curb and control the improper use of drugs, are done by this Institution. Also, promotion of treatment methods and rehabilitation activities field research, lab analysis studies, maintenance of data base are carried out. In addition this board discharges the responsibilities such as coordination with office of United Nations Drugs and crime and International Narcotic Drugs Control Board, responsible in relation to international treaties, supervision of relevant institutions and assistance.

Functions

- Amendment and implementation of national policy on prevention and control of misuse of drugs.
- Implementation of treatments and rehabilitation programmes for drug addicted persons.
- Carrying out prevention and training progerammes for several target groups.
- Carrying out research on tendencies in misuse of drugs, medical, social, legal, economic and cultural aspects.
- Making scientific recommendations based on evidence for policy formulation through chemical analysis and control of precurser drugs.
- Coordination among national, zonal and international institutions engaged in drug control.
