- 02. Bidding Will be conducted through the National Competitive Bidding Procedure.
- 03. Eligible bidders interested in this regard may obtain further details from Chief Accountant, Ministry of Public Security via TP No: 0112 887697 / e-mail : mops.procurementunit@gmail.com or can inspect the bid documents free of charge, from 26.07.2024 to 15.08.2024 between 9.00 am to 3.00 pm on weekdays excluding public and bank holidays at Finance Division, Ministry of Public Security, 17th Floor, Suhurupaya, Battaramulla, Sri Lanka or through our official website (www.pubsec.gov.lk).
- 04. All bidders who meet the eligibility requirements must have legal right to supply the relevant Goods. The bidder must have registered his organization as a business, and if the value of the bid submitted by you is more than Rs.5 million it should be registered under the Public Contract Act No. 3 of 1987. Failure to submit this registration certificate with the bid will be grounds for rejection of the bid. The name of the bidder should not appear in the governments blacklist. Additional details in this regard are provided in the Bidding Documents.
- 05. A set of bid documents prepared in English can be obtained by the interested bidders by submitting a written application to the address Chief Accountant, Ministry of Public Security, 17th Floor, Suhurupaya, Battaramulla, Sri Lanka and paying a non-refundable fee of Fifteen Thousand Five Hundred Rupees (Rs.15,500.00) in cash from 26.07.2024 to 15.08.2024 on government working days from 9.00 am to 3.00 pm. Only one bid form will be issued per bid per organization.
- 06. Bids should be sent in duplicate and can be deposited in the tender box kept at the Finance Division of Ministry of Public Security, 17th Floor, "Suhurupaya", Battaramulla **on or before 2.00 pm on 16.08.2024** or at the time of bid opening or can be sent via registered post to reach before the above deadline. The bid number should be clearly marked on the top left corner of the envelope. Bids received late will be rejected. And the relevant bids will be opened on 16.08.2024 at 2.00 pm at the Ministry of Public Security, 17th Floor, "Suhurupaya", Battaramulla. Bids will be opened soon after the closing time in the presence of bidders or bidder's representatives who choose to attend in person at the same address.
- 07. The validity period of bids submitted shall be from 16.08.2024 to 15.11.2024 (At least 91 days from the date of bid opening.)
- 08. All bids must be accompanied by a bid guarantee of One Million and Fifty Thousand Rupees (Rs. 1,050,000.00) and the bond submitted must be under the following conditions
 - i. As a ¬financial company, it should be a guarantee obtained from a registered institution of the Central Bank.
 - ii. The bid guarantee form shall be in the form contained in Part IV of the set of bid forms.
 - iii. bid guarantee should be in the name of Secretary, Ministry of Public Security.
 - iv. The validity period of bid guarantee shall be from 16.08.2024 to 13.12.2024 (119 days from bid opening date)
- 09. Pre Bid Meeting will be held on **02.08.2024** at **10.30 am** at the Auditorium, Ministry of Public Security, 17th Floor, "Suhurupaya", Battaramulla, Sri Lanka.
